FTS Real Time Client: Option Analyzer

The FTS Real Time Client (Windows Version) has a powerful feature to help you manage the risk of an equity portfolio with equity options.

We will illustrate the use of this feature using the "30 Stocks and Index Options" case and the "<u>Hedging</u> <u>with Options</u>" project. The objective is to take an arbitrary equity portfolio and hedge it with index options only. This write up assumes that you have read the "<u>Hedging with Options</u>" project and that you know how to use the option "Greeks" to hedge risk.

The Option Analyzer window:

- Shows you what would happen to your portfolio-wide deltas and gammas, as well as the portfolio Value at Risk for proposed trades.
- It also shows you the cost of the proposed trades.
- And if you want, you can go ahead and execute the trades in the same window

You access the Option Analyzer by clicking the button outlined here:

• **Recalculating the Analytics**: If you want to update the analytics because prices change, click the "Recalc" button.

- **Stale Prices**: We have checked "Ignore Options with Stale Prices. This is because even some index options don't necessarily trade all the time. If the price is outside the bid-ask spread, we call that a stale price. If the intrinsic value exceed the option price, we call that a stale price.
- **Mid Point for Implied Vol**: It calculates implied volatilities for the options. You can do this in two ways: use the last traded price or use the mid-point of the bid and ask.
- **Beta-Weighted values**: At the top, you see the beta-weighted option hedge parameters. The calculation is explained in the "<u>Hedging with Options</u>" project.
- Value at Risk: you are also shown the 1% and 5% daily VaR.
 - The calculation is based on a simulation using the expected return and volatility of the stock benchmark.
- **Gain/Loss Probabilities**: At the bottom right, there is a table showing you what might happen based on movements in the stock benchmark in one day. In our screen, there is a 5% probability of losing more than 3,279.16. There is a 20% probability of losing more than 1,913.17. If you scroll down, you will see the probabilities of gains as well.

Hypothetical Trades

The post powerful feature is the "what if" analysis. Consider the following proposed trade: sell one contract of the first listed option:

It tells you that if you did this:

- Your beta-weighted delta would decrease by more than half.
- Your VaR would also decrease, almost by half.
- It would require a cash outflow of 12,524.95
 - Because it's a short sale, you would not get the premium until you sold the option; the cash outflow reflects the 50% deposit you would have to put up and the transaction cost of the trade

- You can find more details about this calculation in the "<u>Equity Portfolio</u> <u>Rebalancing</u>" document; even though these are options, the steps in the calculation are the same.
- It tells you the probability of winning and losing: you can see that now, there is a 20% chance of losing more than 951.91, which means an 80% chance of not losing more than that.

Reset will set every option to "No Trade".

The green "Trade" button will execute the trades for you. After you receive all the trade confirmations, click "Recalc." You have to do this manually because it may take a few second to receive all the trade confirmations, and it is much easier for you to see that the trades were done and hit "Recalc."

You can use this to decide what options to buy and sell. You can experiment with different strategies and see what happens.
